Ledyard Public Schools will accept sealed bids from qualified parties to supply and install Eight (10) Epson 1485 FI projectors with finger touch operation or the most recent comparable HD model. Successful bidder is to provide ten (10) Remote plug/volume control stations mounted on the wall for teacher stations. Ten (10) pairs of ceiling speakers mounted in the suspended ceiling for the projectors. Successful vendor is required to include all ancillary equipment required for the proper operation of the system and speakers, to include, but not limited to, mounting brackets, speaker mounts, wiring, wiremold, amplifiers etc.. Owner will provide and install projector boards for the Epson projector units, required AC outlets and Internet connection. Successful bidder is to supply training to the IT staff on the set up and operation of the units and one general training session for staff in each building. Successful bidder is to supply no charge service to the units (excluding vandalism) for a period of two (2) years with a response time of not less than 48 hours.

The project is expected to begin installation in July of 2023 and be completed prior to August 10, 2023. Owner reserves the right to alter final quantities and require delivery and install of units prior to June 2023 if needed. Vendor must certify their ability to provide and install units prior to June 2023 if required. Below is a more detailed description of each school.

- Ten (10) projectors will be installed at Ledyard High School, 24 Gallup Hill Rd., Ledyard, CT, 06339. Two (2) ceiling mounted speakers are to be installed at each location. One (1) control station to be installed at each location.
- Location will be determined by the vendor to provide the best sound quality. All exposed wiring to be wiremold or equivalent.
- Non-metallic wiring channels are permitted with approval if the wall can not be finished.
- Wall mounted control is expected to be in a standard location within each room. Location provided by the owner.
- Allow a minimum of 50' of wire for connection between the projector and control panel location. There will be a mix of block walls and standard sheetrock walls for this installation.
- All rooms being installed are expected to be under renovation during the installation time frame. This section of the work should be planned for August 2022.

Ledyard Public Schools reserves the right to waive minor discrepancies in bids or to accept or reject all or part of any submission. All bid submissions are the property of Ledyard Public Schools and will not be returned to the bidder. Award notification to the successful bidder is expected on or before Friday, August 10, 2022.

It is strongly urged that all prospective bidders notify Wayne Donaldson, Ledyard Public School Facilities Director, of their interest to ensure receipt of any addendums. Bid packages are available on the Ledyard Board of Education web site www.ledyard.net listed under district/finance/bids. The response to all questions will be sent to all firms that have requested bid packages, registered with the Facilities Director or attended the walk through.

(Downloading the bid from the BoE website will not ensure receipt of any addendums)

All bids must contain a certification stating that the bid amount is valid for a period of 90 days from bid opening date. The successful bidder will be required to provide a certificate of insurance and proof of manufacturers certification for the equipment being offered and any applicable State of Connecticut licenses for the work being performed.

All bids must clearly state the equipment warranty information and the successful firm will supply a warranty on labor for a period of two years from the date of completion to cover installation issues or service under the length of the manufacturer's warranty. In addition provide a service response time of not more than 48 hours not including weekends or holidays. Ledyard Public Schools is attempting to standardize the projector and smart TV equipment across all schools so alternate brands of equipment will not be accepted. Alternate models will be considered if they meet the minimum specifications of the original equipment. Bid package must include cut sheets for all the equipment being provided as part of the bid.

Ledyard Public Schools reserves the right to alter quantities.
